# Membership Information

Shadowmoss Plantation Golf Club is a semi-private country club with a Championship 18 hole par 72 golf course, a fully stocked golf shop, driving range, two hard surface tennis courts, a junior Olympic swimming pool, a Nautilus fitness facility, and a full service snack bar and lounge.

Benefits of membership include: Reduced cart fees of \$15.00 for 18 holes and \$8.50 for 9 holes; no green fees; unlimited use of the practice facilities, including range balls; discounts in the pro shop and snack bar; monthly member only tournaments; charge privileges; walking privileges every weekday and after 11:00AM on weekends and holidays; reduced rates on quality golf instruction; tee time reservations may be made seven days in advance; and most of all the camaraderie with your fellow members.

The golf course was designed by noted architect Russell Breeden and opened for play in 1970. Shadowmoss has hosted the South Carolina State Open two times since completion. Shadowmoss was carved out of one of Charleston's original plantations, using its large oaks and beautiful mosaic of ponds and streams. Mr. Breeden created a beautiful blend of nature and Southern charm. Golf Digest rated Shadowmoss "best places to play 3 ½ stars" in 2004.

Shadowmoss also has a Men's and Ladies Golf Association, along with other informal groups that play weekly. Ladies' day is on Wednesday mornings and there is a Saturday blitz for gentleman.

# General Golf Club Rules

## 1. PLAY

- A. All golfers MUST sign in at the Pro Shop prior to their round. This includes players who walk or ride.
- B. All play must begin on Number One (#1) Tee except by prior approval of the Pro Shop Staff or when Double Teeing is in effect.
- C. Foursomes have priority on the course. Twosomes and threesomes will be paired with other players, if possible.
- D. Slow play will not be tolerated. The USGA pace of play rating is 4 hours 15 minutes.

## 2. GOLF CARTS

- A. No more than two people are permitted to ride on a golf cart, including children, unless permission is given by the Club Professional.
- B. Golf carts must stay on cart paths whenever possible. Carts should not be driven around the tees or closer than thirty (30) yards to any green. Special exceptions will be made to those who have physical handicaps.
- C. A valid driver's license is required to operate a cart.
- D. Non playing riders may be required to pay an additional cart fee. This will be at the discretion of the Pro Shop Staff.
- E. Any defect or damage of the golf cart should be brought to the attention of the Pro Shop Staff.
- F. Any damage caused to golf course property or others personal property is the responsibility of the golfer.

## 3. RULES FOR ALCOHOLIC BEVERAGES

- A. Strict observance of any Federal, State, County and City Regulations with respect to possession and consumption of all alcoholic beverages on the premises is required.
- B. You must be 21 years of age or older to consume or purchase any type of alcoholic beverage on the Club property.
- C. Alcoholic beverages may not be brought onto or removed from the Club's property.

## 4. CLUB OPERATING SCHEDULE

- A. Club Office – Operating hours are from 7:30 AM to 4:00 PM Monday thru Friday, with the exception of holidays.
- B. Club Lounge – Operating hours are from 10:00 AM to ? daily.
- C. Snack Bar – Operating hours are 7:00 AM until 4:00 PM daily. Breakfast is available until 11:00 AM.
- D. Pro Shop – Seasonal (Generally dawn to dusk)
- E. The above operating schedule may be changed at the discretion of the General Manager. Closing of the Club due to inclement weather is at the discretion of the General Manager.

## 5. HOLIDAYS

- A. Holidays are defined as New Year's Day, Easter Sunday, Memorial Day, the 4<sup>th</sup> of July, Labor Day, Thanksgiving Day, and Christmas Day or the legal day for observing the above mentioned holidays.

# Initiation Waiver Agreement
